## **Discussion / Decision taken**

### **Welcome Address by the Chair:**

The Chair welcomed the members of the House present in the Meeting.

### **Agenda 1: Review of 15<sup>th</sup> IQAC meeting**

- 1.1. A thorough review of the last MOM was done.
- 1.2. MoM of the last meeting was approved.

### **Agenda 2: Review of online teaching-learning**

- 2.1 The Chair deliberated the need to review the current state of online teaching, learning and assessment mechanisms.
- 2.2 The committee discussed on different methods to efficiently track and meet learning objectives, methods such as Flipped Classroom approach, quizzes, and ICT-enabled tools like MOODLE, YouTube videos, and e-resources and emphasized the need to practice them extensively.
- 2.3 Discussion was focused on boosting student engagement, ensuring effective assessment methods, and continuously improving virtual learning environments to achieve educational goals during the pandemic.
- 2.4 The house agreed that in addition to the above, special assignments may be given and tutorials may be provided to aid syllabus completion.
- 2.5 It is also suggested by IQAC coordinator that extra classes may be scheduled for academically slower students for providing tailored support ensuring academic success for all.



### **Agenda 3: Implementation of NEP 2020 and enhancement of Outcome-Based Education System**

- 3.1 As a part of implementation of NEP, 2020, the Chair suggested emphasizing research and innovation and integrating interdisciplinary education encouraging flexibility and creativity in the curriculum.
- 3.2 The house decided unanimously that the focus should be on creating precise metrics to assess student development making sure learning objectives are fulfilled. It is expected that these methods will improve the standard of instruction and ensure that students gain the required skills and information.

### **Agenda 4: Post-pandemic considerations for resuming offline classes**

- 4.1 The committee discussed the necessity of refurbishing the infrastructure including maintaining the laboratories, classrooms, and other facilities. The objective is to provide a secure and comfortable learning environment for instructors and students alike.
- 4.2 Dr. Nandi suggested continuation to prioritize health and safety protocols for protecting students, faculty, and staff from potential health risks.

### **Agenda 5: Initiatives for research grants**

- 5.1 The Chair deliberated the need for research grants in advancing knowledge, fostering innovation, and supporting the academic and professional growth of students, faculties as well as institutions.
- 5.2 Further, IQAC coordinator suggested that projects can also be made available through collaborations with other academic institutions, and consulting possibilities.

### **Agenda 6: Programming and coding skills among core engineering students**

- 8.1 It is suggested by IQAC coordinator to initiate interdisciplinary courses to learning for core engineering students focusing programming and coding skills so that they are enabled to meet industry needs.
- 8.2 The house agreed unanimously that this will help in building their career through placement opportunities as well.
